We wish to inform the Commission that the Monetary Board, in its Resolution No. 588 dated March 31, 2016, approved the request of Philippine National Bank (PNB) to exercise its call option on its P6.5 Billion 6.75% Lower Tier 2 Unsecured Subordinated Notes ("Notes") issued on June 15, 2011. In accordance with the Terms and Conditions of the Notes, the Notes will be redeemed on June 16, 2016 ("Call Option Date") at an amount equal to the aggregate issue price of the Notes plus accrued and unpaid interest thereon up to but excluding the Call Option Date ("Call Option Amount"). The Call Option Amount shall be paid to all noteholders on record as of June 1, 2016. No transfers shall be allowed from June 1, 2016 to June 15, 2016.

¹ This number includes the 423,962,500 common shares deemed issued to the stockholders of Allied Banking Corporation (ABC) relative to the merger of PNB and ABC as approved by the Securities and Exchange Commission (SEC) on January 17, 2013. The shares are the subject of the Registration Statement approved by the SEC and for listing with the Philippine Stock Exchange.
